### **MANDATORY STANDARDS FOR BUTTON/COIN CELL PACKAGING IN AUSTRALIA**

#### Warnings required on packaging of button/coin batteries:

- 1. The packaging of a button/coin battery must be marked with a warning that is clearly visible, prominent and legible.
- 2. The warning must include the substance of all of the following:
- a) an alert word (such as DANGER, WARNING or CAUTION) with the letters of the alert word in upper case;
- b) a combination of an internationally recognised safety alert symbol and an internationally recognised "keep out of reach of children" symbol;
- c) a statement to the effect that the battery is hazardous and is to be kept away from children (whether the battery is new or used);
- d) if the battery is a lithium button/coin battery --a statement to the effect that the battery can cause severe or fatal injuries in 2 hours or less if it is swallowed or place inside any part of the body;
- e) if the battery is a non-lithium button/coin battery --a statement to the effect that the battery can cause serious injuries if it is swallowed or placed inside any part of the body;
- f) advice to the effect that medical attention should be sought immediately if it is suspected the battery has been swallowed or placed inside any part of the body.
- 3. Without limiting where the warning is marked on the packaging, the warning may be marked on the packaging by:
- a) if there is sufficient space, making all the matters specified in subsection (2) on the front of the packaging; or
- b) if there is insufficient space, marking the packaging as follows:
  - (i) marking the front with the matters specified in paragraphs (2)(a) to (c);
  - (ii) marking the other matters specified in subsection (2) elsewhere on the packaging.


