MI continues to trade and allocate, accept and process orders both incoming & outgoing.

As a company we will do all in our control to ensure our service to you, our valued customers continues with as minimal disruption as possible.

Our Supply Chain is experiencing only minor delays at present which is positive news amongst the negative media hype and fear communications causing panic buying amongst our population.

Any supply restrictions that may arise as a result of delays in manufacturing and shipping out of China or elsewhere are being monitored carefully. This includes our freight forwarding partners to ensure we are communicating any interruptions or delays to our customers.

We can inform you that we are continuing to receive product from many of our overseas & local suppliers. Some logistical channels & shipping locations remain challenging, however almost all port origins are open and are shipping goods.

We have implemented a series of policies to minimise risks for our staff, visiting customers and other onsite personnel.
